AND WHEREAS this Council supports the request in principal however any agreement that the Town may enter into for a Phase II ESA will not be conditional upon student participation. It will be the responsibility of Algonquin College to gain such approval and the terms of what that participation may be from the company contracted to do an ESA on behalf of the Town

AND FURTHER should the Town decide not to proceed with a Phase II ESA on the Chalk River Business Park it grants permission for Algonquin College students enrolled in the program to access the Business Park for the purposes of conducting environmental site assessments as defined in their proposal letter of 23 July, 2014. Town administration will endeavour to assist in providing information and assistance where possible.

AND FURTHERMORE the Town assumes no responsibilities, liabilities or financial support of the project. Algonquin College shall retain all responsibilities and liabilities for the students participating and accessing the Business Park as part of the Environmental Technician Program.
