(a) Mr. Andrew Buzza and Michael Faddock from Jp2g Consultants Inc delivered a presentation and answered questions on the completed Phase I Environmental Site Assessment for the Chalk River Business Park. Given the areas of potential environmental concerns that were identified in the study a Phase II E.S.A. is recommended.

The Town is currently pursuing grants that may help offset costs for additional studies and directed staff to pursue obtaining a cost for a Phase 11 Environmental Assessment.
