- 4. that the Baggs Road trail from the Hydro corridor to Plant Road can be closed for a period of approximately four weeks staring March 17th 2016 for the cutting down of the trees/brush and the installation of the pipeline line.
- that Enbridge Gas will be responsible for posting temporary road closure signs. Installing 5. jersey barriers at each end of the Baggs Trail road allowance as well at any intersecting access trails and for the publishing of notices about the closure in the local newspaper
- that Enbridge Gas shall indemnify and save harmless the Corporation of the Town of 6. Laurentian its servants, agents or employees from and against any claims whatsoever, related to the work on project No. 6.902981 Enbridge file number 1185145.
