WHEREAS the Province of Ontario announced a proposal to expand the "Strong Mayor Powers", as provided for by Part VI.1 of the Municipal Act, 2001, to the heads of Council in 169 additional municipalities effective May 1, 2025;

**AND WHEREAS** the Strong Mayor Powers has raised significant concerns regarding the centralization of power, reduced accountability and alters the balance of governance at the municipal level, undermining the role of Council and decision-making by weakening the fundamental democratic principle of majority rule and diminishes the role of elected municipal Councillors;

**AND WHEREAS** a growing number of municipalities, elected officials and members of the public are questioning the appropriateness of the Strong Mayor system and are calling for its reconsideration or repeal;

**NOW THERFORE BE IT RESOLVED** that the Council of the Town of Laurentian Hills formally expresses its opposition to the expansion of Strong Mayor Powers and requests that the Province of Ontario reconsider the legislation or alternatively permit municipalities to opt out;

**AND THAT** the Town of Laurentian Hills requests that any future proposed amendments to O.Reg 530/22 to expand strong Mayor Powers and Duties to additional municipalities NOT include the Town of Laurentian Hills as a designated municipality for such powers.

AND FURTHER BE IT RESOLVED that a copy of this resolution be sent to the Premier of Ontario, the Minister of Municipal Affairs and Housing, all Regional Members of Provincial Parliament, all Ontario municipalities, and the Association of Municipalities of Ontario (AMO) for their awareness and support.
