WHEREAS the Minister of the Environment, Conservation and Parks (MECP) directed the transition of the Blue Box Program to full producer responsibility and issued new Blue Box regulations to implement full producer responsibility.

# UNFINISHED BUSINESS (Cont'd)

AND WHEREAS Regulation 391/21 Blue Box under the Resource Recovery and Circular Economy Act, 2016 makes producers that supply packaging and paper to Ontario consumers financially and operationally responsible for their products and packaging at the end of life.

AND WHEREAS under the new regulatory framework municipalities transferred responsibility of their Blue Box programs to producers on July 1, 2023 and by December 31, 2025, producers will be fully responsible for providing Blue Box services provincewide.

AND WHEREAS the Town of Laurentian Hills will be transitioning to the full producer responsibility program for curb side pick-up for eligible sources on July 15, 2025.

**AND WHEREAS** the new program does not include funding for the collection, hauling and processing of recycling materials from the convenience depot located at the Baggs Road landfill.

NOW THEREFORE be it hereby resolved that this Council of the Town of Laurentian Hills recommends that with the transitioning to the new program that recycling materials no longer be accepted at the Baggs Road landfill and that Town staff work with the Town of Deep River to implement the closure of and advertising of the discontinuance of the convenience depot.
