#### 2. **DECLARATION OF PECUNIARY INTEREST**

#### 3. **PRESENTATION**

Council received a presentation from Meggan Vickerd, the General Manager of CNL Waste Services and Nicole LeBlanc a CNL Communications Officer on the Near Surface Disposal Facility (NSDF). The presentation included a request for support of the project.

WHEREAS the Canadian Nuclear Safety Commission (CNSC) will hold a public hearing (Part 2) on May 31, 2022 to consider an application from Canadian Nuclear Laborites (CNL) to amend its nuclear research test establishment operating licence for the Chalk River Laboratories (CRL) site to authorize the construction of a Near Surface Disposal facility (NSDF), a proposed engineered containment mound for low-level radioactive waste along with supporting facilities;

**AND WHEREAS** CNL is proposing to construct the NSDF within the next 3 years and operate the waste emplacement facility for 50 years, followed by a 30-year period to decommission redundant supporting facilities with capping and closure of the mound ending by the year 2100;

**AND WHEREAS** the proposed NSDF project requires both an environmental assessment under the Canadian Environmental Assessment Act (CEAA) and licencing approval under the CNSC;

**AND WHEREAS** the deadline to make comments on CNL's application must be filed with the Commission Secretariat by April 11, 2022;

NOW THEREFORE BE IT RESOLVED THAT this Council of the Town of Laurentian Hills is authorized to submit a written intervention in support of the NSDF Project, to the CNSC Commission Registry on or before April 11, 2022, and attend and or participate in the Commission Hearing scheduled to start May 31, 2022 in support of the Town's intervention.
