Provincewide Proof of COVID-19 Vaccination

Current as of September 1, 2021

Effective September 22, 2021

All Ontarians will need to be fully vaccinated (two doses plus 14 days) and provide their proof of vaccination (vaccine receipt) along with photo ID to access certain public settings and facilities. This approach focuses on higher-risk indoor public settings where face coverings cannot always be worn and includes:

- Restaurants and bars (excluding outdoor patios, as well as delivery and takeout);
- Nightclubs (including outdoor areas of the establishment);
- Meeting and event spaces, such as banquet halls and conference/convention centres;
- Facilities used for sports and fitness activities and personal fitness training, such as gyms, fitness and recreational facilities with the exception of youth recreational sport;
- Sporting events;
- Casinos, bingo halls and gaming establishments;
- Concerts, music festivals, theatres and cinemas;
- Strip clubs, bathhouses and sex clubs;
- Racing venues (e.g., horse racing).

Note: These mandatory requirements would not apply to outdoor settings where the risk of transmission is lower, including patios (with the exception of outdoor nightclub spaces), settings where people receive medical care, food from grocery stores, and medical supplies. Additionally, unvaccinated individuals with medical exceptions and people under 12 years of age will be permitted to enter these settings.

Effective October 22, 2021

- Certificates will be issued that include a unique QR code containing similar information as the current paper/PDF vaccine certificate.
- Launch of a new app that businesses and facilities can use to scan and validate unique QR codes.



How to Access Your Proof of COVID-19 Vaccination




Step 1: Visit Ontario's Online COVID-19 Vaccination System

Visit https://covid19.ontariohealth.ca or get a family member or friend to do so on your behalf.

Step 2: Verify Your Identity

- Next step is to verify your identity so that you can be provided with your proof of vaccination. You will need the following to complete this step:
- 1. Health Card (including health card number, 2-letter version code and the 9-character code on the back of the card
- 2. Date of birth (YYYY-MM-DD)
- 3. Postal code (Example A2A 2A2)

Step 3: Access and Print Off Your Proof

 You will now be able to access proof of your first and second vaccination. You can print this proof of vaccination, or take a picture to have it available if needed.

RCDHU will either mail it to you, or you can pick it up at RCDHU's office. Ensure you have your health card handy during the call.
